

FROM THE STAINED GLASS OFFICE - AN OPEN LETTER TO STARFLEET

Over the last few weeks and months, there has been an intense debate over several issues in STARFLEET: what the club should and should not do as time moves on and fandom changes; over things happening and not happening in the club, whether they are right, wrong, legal or illegal; and whether to remain in STARFLEET or to leave. My first reaction was to wonder...is this an event that happens in intervals, or is it something in the water! However, of late we have witnessed some friends and chapters of STARFLEET leave over different issues and that is the thing I want to address today. Folks, leaving STARFLEET accomplishes absolutely NOTHING. It only lessens the organization and lessens yourself and/or your chapter. When I was growing up, my parents taught me an important lesson: something you believe in, something you enjoy is worth fighting for. Yes, I said fighting for. This attitude of getting mad, taking your toys and going home is not taking a stand, not fighting for improvement, not standing for your beliefs, but simply running away, letting what you think to be wrong,

and fear win the day. Shakespeare said it best, "The coward dies a thousand deaths. The valiant taste of death but once." We are facing issues and approaching times in STARFLEET that we must face with courage, determination, and action. The time of running from our problems in STARFLEET is long gone. It is time for us, as the members of STARFLEET, to take a stand that this organization belongs to all of us and she is worth defending. If you feel things are going wrong, be a voice calling for change. Sure, you may stand alone for a time, but if you are right, others will see and join you. One of the greatest leaders of the twentieth century, Winston Churchill, for many years before World War II, was a minor member of government, continually warning about the dangers he saw developing overseas, calling for preparation while some leaders went along, blindly making concession after concession, trying to "keep the peace". If you are right, time will prove it. If you are not, time will prove that also. However, you will find that most people respect those who stand for their beliefs and are willing to speak out for them. If you and your chapter feel things are wrong, then work for change. When positions open up, go after them. When you can speak out, do so. When election time comes, vote your conscience. When an issue arises, and your opinion is asked, give it. If a position comes up for election and you feel you can do the job then run for it, or support a candidate that stands for what you believe. You may not win right away, but you will have the pleasure that only comes when one make a difficult stand, and gains the respect of those who agree...and his or her own self-respect.

One final thought: before someone says, "Get a life, it's only a club," let me say this. I'm finishing this article four hours removed from being in the middle car of a four-car pileup and walking away from one crunched Toyota! Even after that, I still believe that leaving and walking away from this organization is not the answer.

I've made a lot of friends over my years in STARFLEET, and look forward to making more as time goes by. Despite things that I think are wrong, despite decisions that I feel were made in absolute error, despite things that are so clearly politically motivated that it's absolutely transparent, I STILL believe in STARFLEET and am ready to stand up, be counted, defend this organization, and work to see the changes I believe are needed made. I want to ask each of you who read this article to take this stand with me. If you have left STARFLEET, sign back up and work for change. If you are still in STARFLEET, start or continue to work for improvement.

This organization does not belong to any one person, or any one group of people. It belongs to all of us collectively, and that is how we must work for its improvement, together. The notion that we must think alike, act alike, talk alike, smell alike is not unity, but uniformity. What I'm talking about is unity in purpose and for that, we don not have to seem like we were cut from the same cookie cutter.

We talk the talk of IDIC, folks. It's time to walk the walk.





COMPUTER OPERATIONS

COMMODORE MARK ANBINDER

CHIEF OF COMPUTER OPERATIONS, STARFLEET

Imagine, if you will, walking up to Captain Mark H. Anbinder in a hot hotel atrium in Lubbock, Texas, and saying, "Less than two years from now, Mark, you'll be Chief of Computer Operations." Now, imagine my quickly finding you a comfortable chair in one of the few fully air-conditioned rooms at IC '98 and seeking heatstroke treatment for you.

Well, in the almost two years since the 1998 International Conference, I've become more and more active in CompOps, a part of STARFLEET I wouldn't have been able to explain about a year earlier, had you asked. If you're not sure, yourself, I'll help. STARFLEET policy states that use of listservs/mailing list is considered unofficial, and that no punitive actions can be taken by STARFLEET, nor requested be taken by STARFLEET (in its entirety) against anyone for any conduct related to the use of said listservs/mailing lists.

This policy has been stated many times on various listservs.

No punitive actions can be taken by STARFLEET (in its entirety), nor can any actions be demanded of STARFLEET (in its entirety) for any transgressions (real or imagined) that

take place on any listserv/mailing list. This policy has also been stated many times on various listservs.

No one is saying that any one group/unit cannot consider thier listserv "official." However, STARFLEET does not consider it official. The only lists that STARFLEET (in its entirety) considers official are the EC/AB ListServ, the Admiralty Board voting listserv, and the Executive Committee ListServ.

COMMANDER, STARFLEET NOMINATIONS

Vice Admiral Allyson Dyar • Chief of Communications, STARFLEET

STARFLEET will hold its election for Commander, STARFLEET this year. Therefore, the nomination procedure is presented below in order to ensure that the guidelines for nomination are distributed well in advance of any deadlines.

From the Constitution:

ARTICLE 7: ELECTIONS

Section 4: Nomination of Candidates Nominations of candidates for President may be submitted to the Election coordinator by Chapter (but not Chapter-in-Training) COs or Regional Coordinators. nominations must be signed and dated, and no person shall nominate more than one candidate in each election. A minimum of five (5) nominations is required to qualify as a candidate for President. Once a member has been accepted as an eligible candidate for President, that candidate must publicly announce within ten (10) days of notification of eligibility his/her choice for Vice-President.

Candidates for President and Vice-President shall run together as a slate. In this fashion, the office of Vice-President is subject to the general election of the Fleet membership. Section 6: Timetable

The timetable for the election of the position of Commander, STARFLEET shall be as follows:

June 1st to July 15th Nominations for the position of Commander, STARFLEET are accepted.

July 16th Qualified candidates and their choices for Vice-President are announced via the most expedient means possible and campaigning officially commences.

August 1st The deadline for campaign literature to be submitted for publication in the official Election Publication.

September 1st All ballots and Election Publications must be in the mail.

November 15th The CPA hired to conduct the election must receive all ballots by this date

November 20th The winning candidate is notified and incumbent Commander, STARFLEET begins a transition period, if necessary.

December/January Results are announced in the COMMUNIQUÉ.

January 1st The newly elected officials take office.

Notes:

- * Any nomination letters received before 01 June 2000 or after 15 July 2000 will not be accepted.
- * The CO or RC must send nominations in a manner that allows the Chief of Communications to take delivery of a signed and dated letter. Nomination letters can be sent via post office, overnight delivery, carrier pigeon, etc. Email, fax, or any other means of delivery is not acceptable at this time.
- * Any CO who is also an RC can only submit one letter of nomination.
- *The CO must be the president of a chapter in good standing (defined as a chapter that is not decommissioned). The CO or RC must be a member in good standing (membership paid to date and no outstanding bounced cheques). Status of the chapter and the CO as well as the RC will be verified upon receipt of nomination letter.
- * Acknowledgement of receipt (and acceptance) of the nomination letter will be issued if a self-addressed envelope (SASE) or an email address is enclosed.

A NEW CAMPUS FOR A NEW AGE

Starfleet Academy Online is a branch of the Academy for dedicated Internet users If you dislike the wait involved with sending an application, gettingand mailing an exam, and receiving your diploma, the Online Campus is for you.

Currently, some Directors do send and receive exams online. But the Online Academy goes a couple of steps farther. A student can apply online to a school, take the test online, and receive a printable diploma by e-mail. The only snail-mail required is your initial purchase of Online Voucher Codes. Here's how it works.

1. You or a representative of your ship mails a check or money order

for as many Online Voucher Codes as needed. Voucher Codes are one dollar each. These are NOT the printed vouchers used by the regular Academy. Virtual Vouchers are purchased from the Online Academy Voucher Contact (OLVC) Carol Thompson, P.O. Box 135, Ester, AK 99725-0135.

- 2. The OLVC will e-mail you the Code numbers for your Online Vouchers. There will be one Code for each dollar you sent.
- 3. You go to the Online Academy Webpage and choose the course you want to take.
- 4. Fill out the application and list one Voucher Code in each space provided. Most classes will only require one Code, but future ones


- may require two. If you want the director to snail-mail you a diploma, you will add another Voucher Code to pay for the printing, paper, and postage.
- 5. Your application will be processed and, depending on how the class is set up, you can access the manual and take the test immediately or the director will contact you by e-mail and direct you to a website where you can download the manual and take the exam. If you need to do some research, you will be able to return to the examination website later to take your test.
- 6. When you pass your test, the director will e-mail you a printable copy of your diploma (DOC, PDF, or a graphics file).

Once redeemed, a Code is immediately voided. A Code may only be used once.

Success of this program depends on the security of the Voucher Codes. The person purchasing the Codes must share them with no one except a student who is purchasing them from the ship. If a crew member buys 3 Codes from your ship, give that person ONLY three Codes. The rest of the Codes are classified.

Right now there are only a few classes available, but more are being adapted for online use. It takes Greg Staylor and Carol Thompson lots of time to type in manuals and to create online forms for the exams. Keep checking the Academy website for new classes.

KLINGON WARRIOR ACADEMY AWARDS ORDER OF GENERAL MARTOK

Following is a submission which earned its writer a position in the Order of General Martok's Honor Guard.

"A Look at the Klingon Empire's Attempt to Invade the Cardassian Union - It's Premises And Outcomes."

The hostilities between the Klingon Empire and Cardassia begin innocently enough with the crew of DS9 searching all levels of the station for changelings, in a practice drill. They do this because of heightened hostilities between the Federation and Dominion. Shortly after the drills, Captain Sisko finds that the Klingon Flagship commanded by General Martok is in orbit around the station. After asking and receiving permission for shore leave for his men, Sisko finds multiple birds-of-prey de-cloaking; thus the flagship is not alone. The general inhabitants of the station appear nervous with the influx of Klingons around. A meeting takes place between Sisko and Martok to discuss why the Klingons are in Bajoran space. But before the meeting begins, we already see the Klingons paranoia about the Dominion. Martok makes all members of the meeting prove that they are not changelings, by having each cut him or her. After this he tells Sisko that the High Council has sent him to assist the Federation in the defense against the Dominion. And that they believe the Dominion will come. We also learn that Cardassia has closed its boarders. The Obsidian Order has been destroyed and riots may be taking place on Cardassia Prime.

With the attack of Garok (the station's lone Cardassian) by a group of Klingons, we see even more paranoia about a Dominion and Cardassian alliance. We also learn



that there are over 20 birds-of-prey in the area, and possibly more. Their job seems to be stopping and interrogating any ships in the area. The ships are to be searched for changelings. This action is in direct violation of unlawful search and seizure under Bajoran law. They are told not to proceed with this activity (by the Federation) in Bajoran space. At this point the Klingons move beyond Bajoran territory, but continue the "Blockade". We also learn at this point that, "The only people that can deal with the Klingons are the Klingons". This is where commander Worf comes to DS9. His job is to figure out what the Klingons are really up to.

Martok's son is beaten in a non-lethal battle by Worf to draw Martok into a discussion about the Empires true purpose. But he is silent on the matter, as is Gowron and Emperor Kahless. We also learn that the rift between the Federation and Klingon Empire is still widening at this point. Martok has executed one of his commanders for not firing on the Defiant, during the Klingons routine stoppage of a freighter. We learn that Martok's mission will determine the fate of the Empire, though we still do not know exactly what there plans are at this point.

We finally learn (from an ally of Worf's Father) that the Klingons plan to invade Cardassia. This would break multiple treaties and could eventually lead to war with the Federation. Civilians have overthrown the Cadassia Central Command. The Klingons believe that the civilians could not have done this alone and must have had help. The help could have only come from one source, the Dominion. They feel that by attacking now, they will save the Alpha Quadrant, before the Dominion has a chance to establish a foot holds here. We learn that the Federation will not help in the battle. After this disclosure the entire Klingon Fleet moves off to Cardassia. There are many Klingons who feel that they have been too passive over the years, and this information on Dominion activity on Cardassia gives them the

opportunity to continue their warlike ways. Even if this information is false. (Or true as we find out much later when the Cardassias form their alliance with the Dominion.)

In the early battles many Cardassian outposts fall, but thanks to some interesting Federation techniques the

Cardassians mount a good defense, for a while. It is now that the Federation condemns the attack, and Gowron expels all Federation people from Klingon space. He recalls his ambassadors from the Federation and walks away from the Khitomer Accords. Here Gowron also moves into the area to take control of the Cardassia invasion. Gowron is moving even further from the Federation, because he feels the Klingons are doing all the fighting to save the quadrant and the Federation is doing nothing to help their allies. The federation is worried that if the Klingons are successful, what will stop them from moving on to Bajor and eventually the Federation itself.



The Klingons eventually break through the Cardassian lines and move towards Cardassia Prime. The Federation offers to save the civilian leaders of Cardassia in order to save Cardassian rule. Captain Sisko rendezvous with the Cardassian ship that has the officials on board, to find it under attack by three birds-of-prey. Both Federation and Cardassia ships come under heavy fire. An all out last ditch effort starts between the two sides. The Defiant takes the civilian government aboard and makes haste to DS9, followed closely by the Klingons. They arrive back at DS9 and a standoff starts. We learn that almost half of the Klingon force is just outside the shields of DS9. After refusing to give up the Cardassian Council the attack begins. What follows next is a devastating space battle, with both sides taking heavy casualties. Boarding parties make it a space / station battle; again with both sides taking heavy casualties. We see StarFleet arrive at this point and outmaneuver Gowron's troops. After some fast-talking by the Federation, reminding Gowron that, "To lose a war to save an Empire is Honorable". Gowron stands down. The Klingons realize this is actually what the Dominion wanted. If the Federation and Klingons battle each other and weaken each other, it will make them easier to defeat. Even though Gowron has seen his error (by playing into the hands of the Dominion) the rift between the Klingon Empire and the Federation has been made. The rift remains in place until the death of Gowron by Worf in another ill advised attack plan on Cardassia and the Dominion.

HOW TO SUBMIT A PROPER PROMOTION REQUEST

Major General Michael W. Malotte • Director of Promotions

As the coordinator for promotion requests for STARFLEET and the STARFLEET Marine Corps, I see all of the requests for promotions. They come to me through the online form, in email and the US Postal Service. I take all requests for Fleet Captain/Brigadier and above and forward them to the Promotions Listserve, where the Executive Committee votes on them. Once those are voted on, I print certificates for those who have passed, sign them, then forward them on to Fleet Admiral Mike Smith. Once he receives them, he signs them and either sends them to the appropriate individual or brings them with him to the event in which they are being presented.

Those that come in for Captain/Colonel are forwarded to the respective Region Coordinator for consideration.

Occasionally, I get requests for promotions to Commander and below. These are redirected to the appropriate Chapter Commanding Officer. Since Region Coordinators and Chapter COs are the one who approve requests for Captain and Commander and below respectively, it's not possible for me to track those. If you have any questions on those requests, please contact the appropriate RC/CO.

Of the fifty-seven Flag Rank requests received from the 1st of January to the end of April, only eleven were turned down. Of those eleven, most were turned down for one of two reasons. The first is Time in Grade. This was the case in four requests. Remember, to be eligible for promotion, you need to be in your current rank for at least thirteen months, unless extraordinary circumstances are present. That is the

first thing the Executive Committee looks at

The most common reason for being turned down is insufficient information in the promotion request. I've seen quite a few requests that list everything a person has done since joining Fleet - I mean EVERYTHING! While this is great for a Fleet resume, it's not what the Executive Committee is looking for.

When you submit someone for promotion, concentrate on what the individual has done since their last promotion. List, in detail, the accomplishments of the individual. What have they done since then? What positions have they held? How have they gone above and beyond the norm in their position? What is it that makes them stand out above all others in their duties? What have they done *since their

last promotion* to make them eligible for the next promotion? These are the things the Executive Committee are looking for, along with Time in Grade, when they consider someone for promotion.

One last thing to remember - if someone you have nominated is turned down for a promotion, you need to wait a minimum of six months before submitting that person again. If you need to know when someone can be resubmitted for consideration, drop me a note at promotions@sfi.org and I'll be happy to let you know when they are eligible again.

I hope this helps clear up the process and, once again, congrats to all those promoted since the first of the year!

USS CHALLENGER HOSTS COURT MARTIAL

Armed with all the judicial knowledge that one can get from watching numerous episodes of Perry Mason, "The People's Court", "Judge Judy" and of course the classic ST episodes "Court Martial" and "The Menagerie", three judges came together in Millville, NJ on April 15.

They included Admiral Jim Rennie of the UFPI chapter USS Farragut, Tim Reiss, XO of the independent USS Tempest, and myself representing Starfleet.

My ship's Away Team from the USS Challenger consisted of my First Officer Capt. Dawn Weill, Asst. Security Chief Cmdr. Ken, Ops Chief Ken Diehl, Engineer Lt. Josh Neely (who also played a Section 31 Assassin) and Communications Officer Lt. Damien Heppel (who also portrayed a Klingon Ambassador).

Various members of Starfleet, UFPI, Starfleet Marines International and even a few mundanes assembled at the Millville Library for a "mock trial" (and boy did poor former Challenger member, SFMI Col. David Sladky get mocked) His mom even played the Vulcan prosecutor and his brother Mike testified against him (talk about getting your day in court).

Lets just say we didn't always follow the carefully prepared script. We shared a lot of laughs (usually at the expense of Col. Sladky, who like a true marine endured it well). It gave everyone a chance to stretch their creativity, their humor and most of all their imagination. The scenario involved the Colonel's theft of a prototype Runabout, the USS Yukon, from a starbase and then his taking it behind enemy lines in the Romulan Neutral Zone. While the Romulans attacked and destroyed the Runabout, Sladky was recovered and arrested.

The accused then stood trial on Starbase 7 (which up until November I was in

charge of as Commander of the 7th Fleet). As Challenger was in route to our old homeport, Sladky broke out of the brig and attempted to escape. Several members of the Farragut's Marine Unit (including his Klingon half brother Moag) caught him again.

To complicate matters, the Romulan Star Empire demanded his extradition. (This involved some participation via e-mail from Romulan Star Empire Praetor Trisha Rohal, who is the CO of the SF correspondence chapter USS Raven).

The trial involved props, graphic screens, and even a bomb was discovered (although thankfully, Sladky himself was able to save the day, and a good portion of Starbase 7). But a Coridan assassin (played by Josh Neely) also tried to end the day and the life of the same witness. Fortunately, SF Marines were on duty. One amusing moment was noted when all the fracas was going on to stop the assailiant, Cmdr. Dohn was holding the young

infant of the Farragut's XO. Dohn was jokingly accused of hiding behind the child.

Millville certainly got to know David Sladky after that weekend, for you see my own contribution to the event was not only to serve as judge but to hand out and post as many of the Most Wanted posters (which I made) as possible.

The Atlantic City Press's April 16 edition featured a photo of Starfleet/ USS Challenger officer Cmdr. Ken Dohn brandishing his phaser rifle and preparing for action. The headline read "Trekkies hold court in Millville".

The rest of the article revealed some interesting facts I wasn't aware of, that the court martial mock trial was actually a benefit for a good cause. The article by reporter Brian Hickey stated that "a Star Trek fan club court-martialed one of their own Saturday to raise money for the National World War II Memorial in Washington, D.C."

Hickey's article also stated that "somewhere between earthly realities and intergalactic fantasies lies the Trekkie mind-set. And to find that special little place, people had to look no further than the Millville Public Library on Saturday where book borrowers did their business just feet away from costumed Star Trek fan-club members. But behind the closed doors

of a library meeting room, the Trekkies didn't battle about who'd leave with the latest Grisham novel."

"Yeah, I guess we're a little nuts," said 'Admiral' Jim Rennie, a Northfield man in charge of local Trek club USS

Farragut, sporting his white, custommade uniform during a court recess.

"Rennie also knows that the get-together that drew a jurysized crowd from as far away as Virginia is a heck of a way to raise funds for the National World War II Memorial in Washington, D.C. Not only will the fishbowl holding a stack of American currency help meet that end, but Rennie plans to sell tapes of 'Starfleet Marine Colonel David Sladky's Court Martial'."

Boyd who, sporting a black smock and silver Vulcan earrings, did her best to prove that Sladky dishonored the "Federation."

Damien Heppel sporting a very much used rubber Klingon mask, a Klingon

hidden in the courtroom (we were later to learn that it was planted by Section 31 agents who wanted to silence a witness) as he felt that evacuation of the starbase would be dishonorable. What could you expect from a senile old Klingon?

called to the stand. Objections were sustained and denied. Eventually it was revealed Sladky was only working to provide safe passage to a Vulcan Federation agent who was posing as a Romulan. verdict. "Colonel Sladky is hereby released and the charges dismissed. All but one that is. Due to his break out of the brig, Sladky is reduced in rank until July at Shore Leave." To add insult to injury he'd have to serve under his brother now who now out ranked him.

But even with the end of the trial (most of the defense team, prosecution, accused, witnesses, court room audience and judges adjourned to a nearby diner for lunch and to share further laughs) the event didn't quite end there.

The ISS Lexington, USS Justice, USS Raven, USS Starlord and for the first time, the USS Challenger, to name just a few. The scenario picks up shortly after the end of the trial. The Romulans aren't accepting "Starfleet justice" they want Sladky extradited now more than ever. That is the basis of the new scenario and at this writing starships like mine are posed at the Neutral Zone ready for anything if the Romulans should cross over, cloaked or not. As for Sladky, he's preparing to become a human target at the paintball event. But that of course is a report for a later time. One thing is for sure never before was there so many court room cliches heard in one day.

REPLICATORS, SUBSPACE COMMUNICATIONS, AND TRANSPORTERS BECOMMING REAL

Replicators: The replicators of Star Trek are beginning to arrive. They do not yet take feedstock of different elements like oxygen and carbon and replicate hot Formosa Oolong tea for Captain Picard, but they will replicate the cup to put it in. This budding industry is called stereolithography, or making solid, three-dimensional objects from digitized data. The data can be stored on a disk or sent anywhere electronically like any other data.

Mr. Charles Hull of 3D Systems in Valencia, California built the first replicator in 1984. He used it to create a cup about 1-1/2" high. The new technology was unveiled to the public in 1987. Today there are several companies making stereolithography machines, and they are used in many industries where rapid prototyping is desired. For instance, they are used to make art prototypes for lost wax casting of jewelry, epoxy prototype machine gears, auto body parts, cups and plates, and just about anything else that is solid. Any three dimensional object that can be digitally copied into a computer from an original, or designed on a computer, can be stereolithographically replicated. Even data from an X-ray or Magnetic Resonance Imaging machine can be used to make models of body parts inside the body. Right now most things are made in plastic or wax, but within a few years the technology should be advanced enough to do glass, ceramics, metals, and other homogeneous substances. Sanders Prototype Inc. is another company in this business.

In the first replicator, a computer-controlled laser beam was made to dance over the surface of a tank of liquid plastic, hardening the plastic wherever it touched. Then the floor of the tank would lower, letting more liquid in over it. Then the laser would dance over the surface, hardening more epoxy, and so on until the object was complete. Then the floor of the tank would rise, bringing up the entire, completed object.

Another way of making replicas from data is an ink-jet type, spraying hot wax, glass, plastic, metal, or other substance onto the object being created.

Real Trek-type replicators are being worked on as well, in which "assemblers," or tiny molecule-sized arms, take elements like oxygen and carbon from tanks (the feedstock), and directly assemble the desired object one atom at a time. This sounds slow, but the smaller the arm, the faster it can operate, perhaps millions of times per second, and millions of arms would be able to build things very quickly. This technology is a bit farther out in time,

perhaps twenty to forty years at a guess, but in the near term we might see nanomachines doing things like purifying homogeneous liquids such as water and other liquid or dissolved chemicals by selectively passing certain molecules through a membrane and leaving others. The assemblers would be tiny wheels set into the membrane, with receptors on the wheels that can only fit a single atom or molecule of a particular type. It would grab the atoms or molecules from one side of the membrane and transfer them to the other side, leaving behind everything that would not fit the receptors on the wheels. Tiny wheels smaller than a human hair have already been made, specific molecules have been built one atom at a time -- even word lettering has been done one atom at a time, about six atoms tall.

Just search on "nanotechnology," and look at www.foresight.org, which is one of the primary organizations coordinating cutting edge research.

Teleportation: Okay! Here we go with the really good stuff! Teleportation! In the 24 January 00 issue of Defense News it is reported in a long article that all basic systems have been demonstrated for teleportation of information. Not people and things yet, but at least information can be made to disappear at one point and reappear at another, faster than light speed, without traversing the space in between. The information is put into tangled pairs of photons and teleported. The information cannot be intercepted, and includes an encryption key. It can only go to one destination, and the person awaiting it must know it is coming. To know it is coming the receiver must already have been contacted by other means, or at least have a schedule. The equipment may become as small as a cell phone. They did not use the term "subspace transmission," but we are patient. It will not be long.

Transparent Aluminum. The US Army has begun to produce a transparent aluminum compound as helmet faceplates and windshields for vehicles, which gives as much protection as Kevlar, much stronger than aluminum. The material was developed by Jay Conners of the Army Research Laboratory in Adelphi, Maryland. It is made of aluminum oxynitride, 30% lighter and 40% thinner than the multilayer glass and polycarbonate faceplates currently in use. ("Still working with polymers? What else would I be working with?" Star Trek IV)





ASTROMETRICS

BIOLOGY

March 25, 2000: A recommendation has been made by the Centers for Disease Control and Prevention (CDC) that the oral polio vaccine be abandoned in favor of the injection version. Developed by Dr. Albert Sabine, the oral vaccine has been used for nearly 40 years and has played a major role in the elimination of polio. But because it is made with the live virus, it could cause people to become infected with polio. In contrast, the injectable vaccine developed by Dr. Jonas Salk in the 1950's relies on a killed virus. Salk has insisted that his vaccine was safer. Other scientists, though, said it wasn't effective at providing lifelong immunity. But now that polio has been virtually eradicated on the United States, the CDC has decided the risk of the oral vaccine is not worth taking. Currently, children receive two oral vaccinations (a liquid that can be squirted in their mouths) and two injections. Under the new guidelines, which would go into effect next year, children would receive for all four doses of the polio vaccine. (Submitted by Kelly Mangum, from READER'S DIGEST, October 1999)

Environmental Science Fact for the Month (submitted by Dee Okolotowicz)THE AMAZONIAN RAINFOREST - Once a vast sea of tropical forest, the Amazon rainforest today can be compared to a moth-eaten carpet, the dense green pocked and scarred by roads, farms, ranches and dams. The Amazon Basin encompasses areas of Brazil, Venezuela and Colombia and the eastern Andean region of Ecuador and Peru, covering 484 million hectares. Almost all of South America's rainforests are found in the Amazon. Brazil is gifted with a full third of the world's rainforests. It is also one of the world's great rainforest destroyers, burning or felling 2,7 million acres each year. The Amazon Basin formed in the Paleozoic period, somewhere between 500 and 200 million years ago. The extreme age of the region in geologic terms has much to do with the relative infertility of the rainforest soil and the richness and unique diversity of the plant and animal life. There are more fertile areas in the Amazon River's flood plain, where the river deposits richer soil brought from the Andes, which only formed 20 million years ago.





First of all, let me state this right up front, The FDC Program is NOT here to tell you how to run your chapters. This goes for ALL of the FDC Programs, not just Cadets. We are here to Help and advise the corresponding departments on the ships, and that is all. I know that there are some members of fleet who are feeling threatened by our programs. There is no reason for this. There are also those that feel the FDC Program is a duplication of efforts, doing the same thing that the RDC programs do. Well, this may be so, but not all regions HAVE an RDC program. Plus, while the RDC's work within the regions, the FDC's work within STARFLEET as a whole. The main purpose of the FDC program is as a clearinghouse of information for the entire fleet. This is information that we receive from you, the chapters.

<Ok, please excuse me, but I must climb up on my soapbox for a moment>

I have heard a LOT of people complaining about policies that are being set by the FDC's and being forced upon the chapters. To take for example, the Cadet Age issue. I am well aware that this is a very explosive issue, but one that we HAVE to stop skirting. People are complaining that I have unilaterally decided to lock down a set age for cadets in fleet. First of all, this age cutoff is for use within the FDC Cadet program. NOBODY is holding a phaser to anyone's head and forcing them to participate in the program. Plus

I have NEVER said that this is a hard and unmovable wall. Ships will still be able to set their own cadet specs based on what works best for them. But for the Annual Cadet Awards that I was asked to create, there HAS to be a uniform set of age guidelines.

I have been asking people to send me information about any/all cadet programs that are already operating on the chapter level, and have gotten little to no response. This has been going on for over a year now. So if you don't send in your suggestions and ideas, then you have no room to complain when decisions are made. Just like you have no room to complain about an administration if you do not vote and let your voice be heard.

I am aware of the fact that there are some cadets that are more mature then some adults, heck; my chief Science Officer on the Draco is a Cadet. Nothing gives me more pleasure then to give cadets a position of authority and responsibility if they show they can handle it. And I think one of the best examples of this would be Fcapt Dustin Williams. He was Chief of Security for the USS Wernher von Braun while still a cadet and did a better job at it then the adult who previously held the position. So I am in NO WAY saying that cadets can't be department heads as some people have suggested.

One person suggested "Aging", another "Tolerance". I need ideas – got any??



Greetings fellow members. My name is Rick Driver and I have just returned to the position of FDC Science. My job as FDC Science is to facilitate better communications between the regions, local chapters, and individual members of STARFLEET. Another goal of mine is to generate more interest in Science education and Science fun.

Let me tell you a few things about the FDC Science program. First off, no one is required to report to me. You report to your local chapter and your region as required by your bylaws. FDC Science is not part of your chain of command. FDC Science is an information resource.

If you hold a science fair, host a science related away mission, run a science program or anything along those lines, I do encourage you to write an article describing what you are doing and send it to me. Then I can post it on the FDC Science web site and include it in a printed Fleet Science Newsletter, which I will be putting out periodically. Reading about what you and your fellow STARFLEET members are doing will encourage others to participate in your programs and events, or to start their own.

I encourage everyone who is interested in science to get involved. If you have ideas or suggestions, please contact me. This program can only thrive with your participation. Some of the things going on in FDC Science are:

I have invited a scientist from the Space Telescope Science Institute to host a science chat in STARFLEET's Internet chat and she thinks it's a great idea. As soon as we can work out a time and date, I will let everyone know. (If you can't get online for the live chat, don't worry. I will be publishing a transcript of the event in the CQ)

I am in contact with STARFLEET Academy and the FDC Cadet to enable us to mutually support each other's programs.

We have a new STARFLEET Science brochure available for downloadin at

We have a new FDC Science web site with: over 100 links to science related resources on the Internet, a listing of science shows on TV, a recommended reading list, reminders of upcoming NASA missions, articles from fellow members describing their science endeavors. We also have an entire section of ongoing scientific programs that you can participate in.

FDC Science is constantly searching for projects of a scientific or technological nature that might be of interest to STARFLEET members. These are projects that amateurs can get involved in. Most of these projects allow you to contribute to real, ongoing research programs while you learn about the science involved in the project.

Please check out the following projects:

SETI@home is a scientific experiment that harnesses the power of hundreds of thousands of Internet-connected computers in the Search for Extraterrestrial Intelligence (SETI). You can participate by running a FREE program that downloads and analyzes radio telescope data. There's a small but captivating possibility that your computer will detect the faint murmur of a civilization beyond Earth. Be sure to join the STARFLEET International SETI@home Team. The STARFLEET International team currently has over 260 members.

Save Our Streams (SOS) is best known for its biological stream monitoring method, the program has grown to address stream corridor restoration and wetland stewardship. In 1994, SOS started the Stream Doctor(tm) Project to provide citizens with the necessary tools to diagnose stream health, write a prescription for recovery and institute long-term care for the watershed. Started in 1996, the Wetlands Conservation and Sustainability Initiative teaches citizens wetland ecology, function and values, and gives them the tools to participate in wetlands conservation activities such as monitoring.

Thursday's Classroom. The aim of Thursday's Classroom is to provide a lasting connection between NASA's latest research and the classroom environment. We hope you'll become a regular weekly customer by subscribing to our Express News email service! Radio Jove. Jupiter is a source of powerful radio bursts that can produce exotic sounds on ham radio receivers. NASA scientists are helping students tune in to the giant planet as part of an innovative educational program called Radio JOVE.

Project STARSHINE teaches you how to predict when satellites will pass overhead and how to visually track them. Thousands of adults and students around the world report their observations on the STARSHINE web site. The project started when the highly reflective STARSHINE satellite was launched into orbit in June 1999. Now the program has expanded to include tracking and observation of the International Space Station and the Russian MIR Station. Both MIR and the ISS are large enough to be easily visible with the naked eye. The program is FREE. You sign up for the program and report your observations on the web site. All the information you need can be found on the Project STARSHINE web

On 7 May 2000, eight Starfleet chapters converged on Vacaville, California, to compete in the annual Region 4 Summer Challenge. Formerly known at Starfleet WOOZ day, this has been an event in Region 4 since the USS Defiance (a former Starfleet vessel) used to run it back when Rob Lerman commanded her.

The WOOZ closed late 1998 and the event was made more general in nature to accommodate a wider variety of events. This event was hosted by the USS Simonov, the local Starfleet chapter. On this particular day, the following Region 4 chapters from various cities had representation present:

Shuttle Augusta Ada (San Francisco), Shuttle Santa Cruz (Santa Cruz), Cascade Station (Redding), USS Eagle (Fremont), USS Onizuka (Chico), USS Peacekeeper (Fresno), USS Simonov (Fairfield), USS Tikopai (San Jose)

It was a truly incredible turnout despite various changes that occurred due to inclement weather. You see, it was planned as a miniature golf tournament, but a rainy weekend changed that. So some last minute scrambling and hasty e-mails later, the event was moved from Scandia Family Fun Center in Cordelia to Zap City, a Lazer Tag arena in Vacaville.

HOW TO BLOW UP STARSHIPS REAL GOOD!

Imagine, if you will, a Shuttlepod, a happy little Shuttlepod, careening wildly around its parent vessels, the Enterprise E and a Defiant Class ship. Such a cute little Shuttlepod! But then, something evil materializes above, and immediately dispatches the Enterprise-E with a vicious cutting beam! It looks like a cross between a... Pokemon and a Shadow Vessel? Picachu from Z'hadum??? It then pursues the hapless Defiant class and destroys it in a rolling maneuver. Poor little Shuttlepod,

its parent vessels are gone, left alone in a hostile universe with a vicious Shadow Picachu out there hunting it. Will it be vaporized? Will it be sliced in two? NO! It's going to be spun on the tip of a Shadow spine like a basketball player spinning a ball on their finger, batted around the spines, and finally slam dunked into an asteroid in a brief if spectacular explosion!

This is, of course, a parody of the second movement from Fantasia 2000 that I have titled A-Poke-Lypse Now. I enjoyed Fantasia 2000, but that insufferably cute little whale annoyed me, and it just had to pay. Alas I don't know how to animate a whale, I do know... or rather, am learning how to animate Starfleet vessels. Even Babylon 5 Shadow vessels, but first modifying them to look like a Picachu (something else that deserves to be parodied at every opportunity)!

So, in winter of 1999 I embarked on my latest animation project, this time also

as an exercise to polish my skills with a newly purchased copy of LightWave version 5.6. LightWave, as you may know, is the same mid-range 3D animation product used first on Babylon 5, then later on Star Trek Voyager, and the animated series Roughnecks (The Starship Troopers Chronicles), just to name a few. It offers high-end workstation functionality at desktop PC price.

Polygons, Points and Surfaces, Oh My!

A 3D object typically is some kind of wireframe, composed of polygons. These polygons can be given attributes, individually, or en-masse (although typically enmasse). A group of polygons with the same attributes is called a surface, and you can apply bitmaps to a surface in order to give it texture. Or you can just set





Figure 1: A hapless Shuttlepod is batted around the spines of the Shadow-Picachu

attributes of the surface, and still have a pretty kewl looking mesh. Shadow vessels, from Babylon 5, use a procedural texture, calculated at runtime, called Veins. I remember the first time I saw a shadow vessel, with glistening, moving surface texture, and thought it was probably pretty difficult to create. In fact, it's one of the easier textures to apply using Lightwave. (I had far more difficulty creating luminescent fireballs reliably).



Lightwave offers attributes such as surface color, diffusion (how much light is reflected), specularity (how much of a kick – or bright spot – is reflected from a light source), transparency, luminosity (does it glow?) or a bump map. A bump map is just a grayscale image that creates impressions in the texture whose depth is based on whether the pixels in the bump map are light (shallow) or dark (deep). With Lightwave you can also layer textures for a given attribute. I'm using this trick now with a Stardock mesh to give its surface more of a constructed look. (You get the impression of a larger structure/skeleton underneath the surface). You can also give a texture movement, specifying how far it moves each frame. The Shadow vessels vein surface has a slight motion applied to it

in order to give it more of an organic feel (in addition to the fact that the veins themselves shift and change shape).

You an also apply texture maps in different ways. Spherical, cylindrical, cubic projection, etc. A planet, for example, is just a sphere (the more polygons, the smoother it is), with a texture map of the Earth's surface applied using spherical projection. Trust me, cubic/cylindrical projection would create a very odd looking planet!

Energy Beams—Made Simple!

For shadow cutting beams, I went back and studied early episodes of Babylon 5, and Dave Scott's work on a publicly available Shadow mesh, and discovered a surprising fact. The Shadow beam is actually two octagons nested inside of each other, and extruded like a straw. The outer "straw" is semi-transparent, with a red fractal noise texture and some luminosity applied. The inner straw is purple and glowing fractal noise surface color textures, with more luminosity applied. Because the outer straw is semi-transparent, it gives a nifty beam effect. Go back and watch "Signs and Portents" and you can see it very clearly (if briefly!) when the Shadow beam cuts the Raider ship into pieces.

Prelude with Bryce

Previously I had been working with MetaCreations Bryce, an excellent and relatively low cost 3D tool for creating landscapes. It also makes as a decent animation engine, however it is limited in its ability to import meshes from other packages. My first effort discovered either a limitation in the product, or in my ability to use it, and centered on control of the camera. If the camera moves at all during a scene

rendered by Bryce, it does so on a smooth curve. This is not always a good sometimes you want the camera to move, stop, move some more. Bryce would not allow this to happen and you could end up with a rubber-band effect yanking the camera in unexpected directions if you tried to do too much.




Figure 3: The Shadow-Picachu strikes!

result of a real fast approach, but a long, lingering withdrawal. I also moved the camera from time index 4:00-16:00 to give the impression we were following the Danube as it entered a nebulae.

By using forced perspective, I did not have to scale the nebulae sphere the Danube was entering to the same scale as the Danube. In fact, it's not that much larger, but the finished product gives a much different impression (it's light-years across, baby!) thanks to the forced perspective of the Danube.

Lightwave's NULL Objects and Motion Graphs

When I migrated to Lightwave, one of the earliest features I discovered was the Null Object. NULL object's have all the properties of meshes: size, position, and orientation — but do not render in the finished product. Further, you can parent objects together, and child objects will inherit any changes over time made to size, position and orientation. This cannot be overestimated in its usefulness, as when I was destroying the defiant class vessel, I actually had a set of about 8 null objects, parented to a single null object. To each null object I had parented portions of the Defiant mesh that I had already cut apart. Then I could spin one null object, and the warp nacelle would break away, but still be moving with the same forward velocity as the parent null that represented the ship's motion over time.

Another neat feature, fixing the aforementioned path problem in Bryce, is motion graphs. In Lightwave you have complete control of position, orientation and size. You can let Lightwave fill in the blanks between two keyframes, or you can tell it to ignore the previous keyframe, just look at the settings for this keyframe and use them. In other words my camera and my objects no longer have to move in smooth, sweeping curves. They can start, stop, pivot, grow, shrink, spin on any axis with

c o m p l e t e impunity. Further, you can save these keyframes as a "motion graph" and then reuse the graph with other objects.

Another useful instance of NULL objects and motion paths came when I cut the Enterprise-Ein two. I parented each piece to a null object (since each piece was actually made up of several

meshes). I saved the motion of one null object, when I had it right, and then loaded it onto the other half of the ship's null object, and inverted the motion in the x axis and rotational heading. This gave the impression that each piece was moving away from each other, but while at the same time sharing pitch, bank, Y and Z axis motion.

You can also target lights and cameras at objects, null or otherwise. One thing I do now for every new scene I create in Lightwave is target the camera at a null object called CAMERATARGET. In one scene, I wanted to follow the path of the Shadow-Picachu's energy beam from the Shadow vessel to the Enterprise E which was in the process of blowing up at the time. I kept the camera relatively motionless in space, but slammed the CAMERATARGET null object from the Shadow-Picachu's position across the scene to the exploding Enterprise-E. The camera, using that null object as the target, kept it centered the whole time. Add some zoom in/out and you have a nice whiplash camera move that keeps it pointed exactly where I want at all times. To manually position the camera and have it go exactly where I want with keyframes alone would have been much more difficult (as I learned using Bryce).

Between null objects and motion graphs, the rubber band effect in Bryce is completely eliminated and controllable in Lightwave.

Making Things Go Boom REAL GOOD!

Explosions are, of course, one of the more enjoyable and popular parts of animating

Fun With Key Framing and Forced Perspective

How does animation work? Bryce and Lightwave both use key framing. That is, you set the position, orientation, size of your meshes at specific time intervals, and the rendering engine will "fill in the blanks" for all of the frames in between. Typically I animate for 30 frames per second, and will create keyframes for objects about every 4-10 seconds. Even the camera can be positioned (adjusting the focal length instead of the size) using keyframes. The more sophisticated animation tools will provide tools to graph position (X,Y, and Z dimensions), orientation (heading, pitch, and roll) and size (in the X, Y, and Z axis), and even allow you to repeat the graph. One trick I use frequently is set up a scene for 200 frames (about 6 seconds of animation), and set it to repeat itself, and make the scene 600 frames long. Then I'll change the camera position dramatically at frames 201 and 401, so that I get three copies of the same sequence, but with different camera angles in each sequence. In A-Poke-Lypse Now, this is most obvious in the first 45 seconds as I switch position from behind/ to the side/ and in front of the Shuttlepod as it careens happily around the Enterprise E and Defiant-class vessel.

One of the neat tricks key framing gives you is the ability to use forced perspective. One of my earlier projects showed a fast flyby of a Danube class runabout. At frame time index 0:00 I sized it down to size 0 at some distance from the camera. At time index 4:00 (seconds), I sized it to full size and positioned it right in front of the camera. At time index 16:00 seconds I sized it back down to zero. This gave the

space scenes. I started with inspiration from a column by former Foundation Imaging guru Mojo, who did a lot of the early work on Babylon 5. He wrote a column about how he accomplished the destruction of a Narn ship in the second episode of Babylon 5's second season ("Revelations" and used in the season 2 opening credits). I emulated his work in the death of the Enterprise E, when a ShadowPicachu beam slices the vessel in two. The trick is to take a sphere, and shrink it down to size zero, and parent a light to it with lens flare enabled. (Lens Flare gives a halo effect around a light, enhancing its glow). The trick is to make the lens flare so its range of casting light is very small, like 1mm, otherwise one you parent about 200 of them onto the edge of the ship, it will wash the entire scene out in white light. Which is exactly what happened the first time I tried it! I positioned my lights along the cut between the two pieces of the ship, and timed them via motion graph to come on at specific key frames (frames 25, 30, 35, 40, 45, 50, 55, 60, 65, 70). The shadow beam would

slice through the ship between frames 25-75, and this gave the effect of glowing, vaporized hull plate that tracked the progress of the beam. I also adjusted the motion graph of each piece of the Ent-E to "snap" between frames 70-75, moving very rapidly, and then moving slower following frame 75. This gave the impression of the keel breaking. Finally, I placed a swarm of one point polygons, particles really, in between the two pieces and had them expand in size rapidly over about 15 frames, adding glow effects, to look like a debris cloud.

Flaming Balls of Gas

For the death of the Defiant class vessel, I had cut it up into about 8 pieces, and timed them so that they would start spinning away from the ship in sequence. Each piece would start moving, and then after about 10 frames, I set its transparency to zero. At the same time, I added a number of spheres with layered textures to create the effect of exploding balls of gas and flame. Each sphere had the same texture, but was sized and positioned differently, semi transparent, and created a nice effect.

Just Call Me (Render) Farmer Don!

Render times were slow. I started out using a Pentium Pro 200 Mhz, and it was not uncommon for some scenes to take days to render out. By the end of the project I actually had a small network of machines and could actually create a fair amount of animation (10-30 seconds worth) overnight instead of over a period of days. This is a process known as render farming, and Lightwave supports up to 1000 processors working on the same scene at once. There is, of course, diminishing returns after probably about

25, unless you have scenes that take forever to render. On average, I tried to keep each frame down to about 1-5 minutes. Anything more than that and you probably need to go back and seriously simplify what your trying to do. Or do it in pieces and composite the results together in an editing package like Adobe Premiere. Lightwave also had some composting features, so you could "mask out" parts one image, and overlay it onto another. Sometimes this is the only way to get lighting on more complex scenes to work.

Flaming Logo's Are Not That Hard

The final thing I did was the titles. Video Concepts is a company that has photographed various types of explosions, and then turned them into a sequence of

image files. You can probably see their work most blatantly in South Park, the Movie, as the flames erupting in Hell are from Video Concepts Pyromania series of CD's. I used one sequence, a "fire wipe" of flames rising from the bottom of the screen to the top, as the background image for the title. I then used an alpha image (a black and white image that determines what is visible and what is not) to limit the flames just to the shape of the letters of the title. Using Adobe Premiere, I composite this as a matte onto the opening three seconds of the animation, with the results shown below.

I had taken the Apocalypse Now movie logo, and replaced three of the letters with a Pokemon font. The results were a bit jagged, because I didn't have a high resolution Apocalypse Now movie logo to work with, but the flames catch the eyes attention and only an astute observer would notice the resolution of the letters themselves is a bit weak.

What Do You Mean 1.6 Gigabytes is Too Big???

I made the choice early on to make this project letterbox (actually cinemascope resolution), a choice that came to haunt me in the end. The files were just huge. I managed to get some nice benefits from Intel's Indeo codec, but the final 2 minutes and 41 seconds of animation came out to be 1.6 Gigabytes in size (800 Meg zipped). Just way too big, and frankly, anything less than a Pentium III 500 Mhz Dual Processor box isn't going to display it gracefully.

Thanks to Region 5's Gawd-like Regional Coordinator, Kurt Roithinger, I discovered a nifty video/audio compression tool called BINK, which cut that 1.6 Gig bad-boy down to 38 meg in size (37 meg zipped). Bink claims that I can run this on a Pentium 133Mhz, but you still need a little more processor UMPH to pull it off. I'm going to try minimizing the sound quality a bit and see if that makes it both smaller and able to run on slower machines.

Even better, Bink does not require you to install any codec's. It creates a self-executing animation that does not depend upon what you have installed on your machine—as long as its running Windows 9x or NT—your fine.

Coming Soon: A-Poke-Lypse 2000! The Revenge!

Overall, it took about four months of work, and probably a good 2+ months of solid rendering across three machines. Unlike previous efforts with Bryce, I also generated a nice library of explosion and

laser effects that I can recycle in future efforts. I have several other animations planned, including a sequel to A-Poke-lyspe Now in which the ships of Region 5 exact their revenge for the destruction of the hapless little shuttle pod.

I'm not entirely convinced my DSL service is reliable, but for those of you with fast internet connections, you can download it from http://63.226.248.113/3DGallery.html.

can learn a lot there just be hanging out in the forums, and occasionally they give away some of their kick-butt meshes (May was a very good month for this).

I also have to say that most of my work in A-poke-lypse Now was setting up the animations, and very little actual creation of meshes. I modified the Ent-E mesh to cut in two, and Picachu-ified the Shadow mesh, but without the generous attitudes of a lot of folks, this would still be a work in progress.






Figure 7: The Enterprise E Gets Cut In Two




Figure 8: Ouch! That's Gonna Hurt!




Figure 9: CRASH & BURN!

ALUMINUM -The rest of the story

Many moons ago, before what is now the USS Morning Star was officially launched as a shuttle, five Starfleet crewmembers (three newly enlisted) came together in the late August heat of SW Oklahoma to carry out our first recycling for charity endeavor. Odds and ends of scrap metal, some glass bottles, and bags and bundles of newspapers, as well as a few aluminum cans netted us a grand total of \$2.79. I had just received a brochure from a Caribbean-based non-profit organization known as Food for the Poor, committed to providing food, medicine, and shelter for some of the poorest inhabitants of Planet Earth. At the bottom of the last page was a photograph of a simple wooden hoe (for \$2.79!), and beside it a picture of an impoverished man who could not afford even this basic agricultural tool. We shall probably never meet the farmer for whom our small effort made possible the gift of the wooden hoe, but we had the pleasure of knowing that we had helped to give life to our cherished Star Trek ideals and to our Morning Star motto, "Whatever it is, let me help."

Over the more than six-and-a-half years since then, we have continued our recycling efforts, with all proceeds still going to charity. Thanks to an enterprising citizen in our local community, we have lately been able to add #1 & #2 plastic to our cashgenerating items, and more recently still,

computer paper (and we all know how THAT piles up!). We no longer receive money for "tin" (steel) cans but are able to recycle them anyway, thanks to the facility at adjacent Fort Sill. The recyclables for which we are paid - clear and brown glass, newspaper, computer paper, occasional scrap metal, plastic, and, above all, ALUMINUM, continue to produce the "clink of coins in the cup," enabling us, for the past six years, to adopt a whale (via the International Wildlife Coalition) and always have a little extra cash on hand to give added help to the local Humane Society, to which we regularly contribute - apart from recycling funds—food, bedding, litter, and toys. This year we are thinking about a recycling donation to Bat Conservation International, to help spread "the good news about bats." Most of these contributions come from the crew. Of course, some are much more involved than others, but "Infinite Diversity" is one of the basic tenets of Star Trek, and there are MANY ways to help. As CO, I oversee the collection and distribution of all funds. (So far, no one else has requested assumption of THIS responsibility!)

My own recycling has continued chiefly in the direction of our initial charity effort. Some years ago I organized and still maintain a Corps of Civilian Contributors (CCC) made up largely but not entirely of little old persons like me who toddle up to my carport with

offerings of newspaper, glass, plastic, and aluminum. Thanks to their assistance in contributing and my commitment to toddling off twice a week or so to one or more recycler's, a modest but steady sequence of cash contributions has made its way to the desperately impoverished Caribbean. Because FftP buys and ships in bulk and receives fairly frequent matching grants, a little money can go a long, long way, not only toward helping to provide the basic necessities of life but also, in the words of Edith Keeler (TOS, "City on the Edge of Forever"), toward helping to move us a little closer to giving "each man hope and a common future."

My reason for emphasizing aluminum (paragraph two, above) is twofold: (1) the simple arithmetic of recycling proceeds and (2) Starfleet's involvement with Ronald McDonald House Charities (RMHC). Glass brings in only 1/2 cent per pound, newspaper 1/2 cent at one recycler's and 1 cent at the others. (Guess which one I go to!) Plastic brings in 1-2 cents per pound. Computer paper runs at 1 cent per pound or thereabouts. In the years that we have been recycling for charity, aluminum has never gone below 30 cents per pound, and is presently at 42 cents - 84 times what we are paid for glass, 42 times what we earn for newspaper. So why go to all this trouble and spend all this money for transportation of goods when the returns – except for aluminum – are so

small? Well, it all depends on perspective. As I see it, we're engaged in carrying out our mission of serving Starship Earth, and the time, effort, and money are simply added contributions toward the fulfilling of our mission. As to the RMHC involvement, last year the USS Morning Star delivered to the Ronald McDonald House in Oklahoma City 10.5 pounds of aluminum tabs, every one of them pulled by SOMEBODY from aluminum can. I don't know what happened to the other cans from which the tabs were pulled, but I know what's happened to the cans from which *I* pulled 2,291 tabs because I recycled them – all 132 lbs, with every precious penny going to Food for the Poor. Aluminum recycled by the rest of the crew combined added up to 31 lbs, with the proceeds directed toward various charities.

Starfleet's RMHC Director, Lorrie Nelson-whom I thank for helping inspire me to write this article - asked me recently what my secret is for doing what she called an "absolutely fabulous job" of recycling aluminum. In response, I said that my secret is threefold: 1. an unflagging love for Starfleet, 2. a strong desire to serve my fellow-beings, and 3. plain mule-headed determination (BORN to it in my beautiful home state of Missouri!) Right now, five overstuffed bags of newspapers, assorted glass bottles, a few "tin" cans, a moderate stack of computer paper, odds and ends of plastic, and a small sack of aluminum cans (tabs pulled!) reside temporarily on my carport, in front of a sign bearing the inscription "21st Street Mission." Inside, atop my diminutive refrigerator stands a miniature replica of Sister Edith Keeler, arms outstretched, coffee cup in hand, serving as an enduring motivator when my energy flags, which it seems to do more and more often as the years go by. Am I tired FROM recycling for Starfleet? YESfrequently. Am I tired OF recycling for Starfleet? Not yet! And, the Great Bird willing, I won't be for a long, long time.

The Office of the First Brigade Chief Surgeon is now accepting applications for the following two positions:

Sergeant Major, Medical Corps, 1st BDE Chief of Staff, Medical Corps, 1st BDE

As SGM, Med Corps, you will be responsible for reporting to the Chief of Staff on all units with a non-com as the

Chief Medic (mostly all units) in the Brigade. You will also keep all non-com medics informed of any new changes to the TRACOM facility. This is an open ended job description, meaning whatever the Chief Surgeon or I ask you to do, it must be done.

A CoS, Med Corps, you are responsible to me for ALL unit reports that have a medic. The units with a non-com Chief Medic will report to the SGM, who will compose a report to be made to you. You are then responsible for obtaining a report from all other units with an officer as the Chief Medic. You are also Vice Editor-In-Chief of a newsletter when we get one started. As CoS, you are considered part of the Chain of Command. If there seems to be a problem, you have the semi-authority to fix it. Also, if the BN OIC does not mind, you will have the authority, pending the

Chief Surgeon and my approval, to appoint a BN Chief Medic to aide you in your reporting. This is an open-ended job description, so whatever the Chief Surgeon or I ask you to do, it must be done

I don't need anything fancy: a description of who you are, what you have done, and what you plan to do if appointed will be sufficient.





The Logo was based on an original submitted by the USS Challenger and re-worked by the above three artists. The seven stars in formation around the tip of the Space Shuttle are in commemoration of the seven Astronauts - Michael Smith, Dick Scobee, Judith Resnik, Ronald McNair, Ellison Onizuka, Gregory Jarvis, and Christa McAuliffe - who perished in the Space Shuttle Challenger disaster.
